Preamble

WHEREAS, **ICAR – Central Agroforestry Research Institute, Jhansi** is actively engaged in research on all aspects of Agroforestry alongwith its 37 centres located in different agro-climatic zones of the country.

WHEREAS, **Dr. Yashwant Singh Parmar University of Horticulture & Forestry, Nauni – Solan (Himachal Pradesh) – 173 230 INDIA** is fully determined to undertake teaching, research and extension for socio-economic development of farming community.

Now, therefore, both **ICAR- CARI, Jhansi** and **Dr. Yashwant Singh Parmar University of Horticulture & Forestry, Nauni – Solan** desires to undertake collaborative research, teaching and sharing of scholars to Human Resource Development and increase impact of collaborative research as per the terms and conditions mutually agreed upon.

General Terms & Conditions

It is agreed that the collaboration between **ICAR- CARI and Dr YS UHF** be established in the areas of mutual interest to both the Institutions for joint research and Human Resource Development.

1. **ICAR- CARI, Jhansi** agrees to extend its infrastructure, laboratory, library facilities and logistic support to scientists/ faculties and researchers/ PG students of **Dr YSPUHF**.
2. **Dr YSPUHF** agrees to extend its infrastructure, laboratory, library facilities and logistic support to scientists/ faculties and researchers of **ICAR – CARI, Jhansi**.
3. **ICAR- CARI, Jhansi and Dr YSPUHF** will make endeavor to submit joint research proposals.
4. Emergence of any **Intellectual Property Rights (IPR)** from joint research shall be filed by PI/ Project leader of either organization with equal IPR to both organizations and cost will be equally shared by both the organizations. Also, money accrued by way of commercialization of the Intellectual Property thus protected shall be shared equally.
5. Research findings as a result of collaborative work shall be published upon mutual consent among the researchers of both the Institutes according to normal academic practices. The cost, if any, will be shared in proportion to the contribution.
6. Both **ICAR- CARI, Jhansi and Dr YSPUHF** agrees to facilitate exchange visits of scientists/ faculties and researchers/ PG students for mutual research interest.
7. Both **ICAR- CARI, Jhansi and Dr YSPUHF** agrees to include scientists/ faculties as Major Advisor/ Co-Advisor/ Member of the Advisory Committee of PG and Ph.D. students of **Dr YSPUHF**.
8. Both **ICAR- CARI, Jhansi and Dr YSPUHF** agrees to exchange planting material/ germplasm for testing and evaluation at respective locations.
9. **ICAR – CARI, Jhansi** agrees to provide specialized trainings to researchers of **Dr YSPUHF** and vice-versa.
10. Financial obligations (consumables, travel, boarding and lodging, etc.) will be met the respective Institutes.

11. The implementation and regulation of MoU shall be monitored and discussed by the **Director, ICAR- CARI, Jhansi** and **Vice-Chancellor, Dr YSPUHF** from time to time and any interim modification/alteration that may be necessary shall be brought into force.
12. The MoU shall come into force with immediate effect and remain valid initially for a period of **05 (five) years** with effect from the date of signing and shall be extendable further on mutual consent of both the parties.
13. Any other items to be decided mutually by both the Institutions.

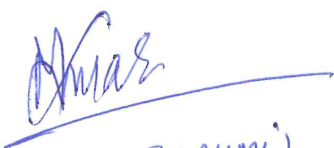
